# **KEY TO NOTE**

- Landscaping reinstatement work to the podium area between Egret Heights and Kingfisher Heights has been paused until waterproofing remediations have been undertaken to the same area by a third-party contractor (designed to help reduce water penetration to the car park beneath).
- Façade remediation works to Kingfisher Heights have been completed and EWS1 certificates have been provided to your Property Manager - request a copy directly from Pinnacle Housing.
- Façade remediation works to Lapwing Heights are in their final stages (with the Rockpanel Cladding expected to complete imminently, and the remaining Carea Stone Cladding progressing well too) – with works tracking ahead of programme.
- See the page overleaf for an update on Eagle Heights (the Building Safety Regulator has informed us it is extending the deadline, meaning work is unlikely to commence until early 2026).

# **PROGRESS UPDATE**

# **Kingfisher Heights**

Landscaping reinstatement work to the podium between Egret Heights and Kingfisher Heights has been paused until waterproofing remediations have been undertaken to the same area by a third-party contractor (designed to help reduce water penetration to the car park beneath).

These waterproofing works are part of a wider agreement between Pinnacle and Bellway Homes Thames Gateway.

Façade remediation work to Kingfisher Heights have been completed and the scaffolding removed – minor snagging to the ground floor will be completed shortly.

## **Lapwing Heights**

Façade remediation works to Lapwing Heights are in their final stages with the Rockpanel Cladding anticipated to complete imminently, and the Carea Stone Cladding will be completed over the coming months (as the scaffolding is struck from the building).

Decking has been completed to all but a small number of balconies, these are anticipated to be completed shortly.

Residents are reminded not to access balconies during the fire safety remediations - as they pose a danger to personal safety. A restrictor has been installed to your balcony door (this will prevent access out to the construction area but will maintain some ventilation to your property.

# **Eagle Heights**

# **Building Safety Regulator Update:**

Regen Facades submitted a detailed application to the Building Safety Regulator on 16 June 2025; this ensures the proposed works meet the functional requirements of the Building Regulations before we commence – it is a necessary first step and a statutory requirement.

Our application has been validated and the content of the submission has been accepted, subject to a review by a Multi-Disciplinary Team from the Regulator.

The Statutory Determination Period is 8 weeks for 'Fire Safety Remediations' but the Regulator is experiencing severe delays for Building Control Services.

The Regulator has informed us that they are extending the deadline by an additional 142 calendar days to review the application, with the new Determination Date now advised as on or before the 31st of December 2025 – this is disappointing but consistent with delays they are experiencing at the Regulator.

Our team continue to request updates from the Regulator, and we will commence works as soon as we are given the necessary permissions to do so.

It is unlikely that works to remediate Eagle Heights can commence this year as a result – further updates will be provided as we hear more.
